## In-person attendance

The venue address is Bd Auguste Reyers 80, 1030 Brussels. The Mesier tram stop and the Diamant bus stop are both close by and there is ample parking available in the underground carpark at the venue (however parking fees apply).

Registration will open at **09:00 CET** and the programme will run from **09:00 - 16:00 CET**, followed by a drinks reception, which will run until around 17:00 CET.
